Dates, Eligibility & Mode of Application

Chhatrapati Shahu Ji Maharaj University (CSJMU) Kanpur announces Call for Applications for Entrance Test for PhD Admission 2022

CSJMU Kanpur PhD Admission 2022 – Online applications are invited from eligible candidates for admission to PhD (Doctoral of Philosophy) Program for academic year 2022.

The Applicants who meet the required eligibility may apply for the PhD Degree Program of CSJMU Kanpur (Formerly Kanpur University).

About the PhD Program

- CSJM University for providing admissions to the PhD Programs for session 2022-23, will be conducting the “Chhatrapati Shahu Ji Maharaj University Entrance Test (CSJMU-ET)”.
- CSJM University is offering admission to PhD Program 2022 in various disciplines as per UGC (Minimum Standards & Procedure for Award of PhD Degrees) Regulations 2016 and amended CSJMU PhD ordinance **2021-22**.

Duration

- PhD Program shall be for a minimum duration of three years and a maximum of six years.

PhD Program is offered in

- CSJMU invites applications for Ph.D. in disciplines of Science & Engineering, Arts and Humanities, Social Sciences and Management. Online applications are invited in Agricultural Economics; Agriculture Entomology; Agronomy; Biochemistry; Biotechnology; Botany; Business Management; Chemical Engineering; Chemistry; Commerce; Computer Application; Computer Science & Engineering; Defence & Strategic Studies; Drawing & Painting; Economics; Education; Education Training; Electronics & Communication Engineering; English Literature; Genetics & Plant Breeding; Geography; Hindi Literature; History; Home Science; Horticulture; Journalism & Mass Communication; Law; Life Long Learning & Extension ; Life Science; Mathematics; Medical Biochemistry; Medical Laboratory Technology; Microbiology; Music; Pharmacy; Physical Education; Physical Education/Yoga; Physics; Physiotherapy; Philosophy; Plant Pathology; Political Science; Psychology; Sanskrit; Sociology; Soil Conservation; Soil Science; Statistics; Urdu; Zoology.
- **Eligibility Criteria for CSJMU Kanpur PhD Admission 2022**

Subject to the conditions stipulated in UGC Regulations-2016, the following persons are eligible to seek admission to the PhD Program:

- The candidates should have Master's degree or a professional degree (M.Tech./LL.M./M.D./M.S. degree) in the concerned or allied subjects (as mentioned in information brochure) provided that a candidate holding a Master's degree in an

allied subject may also be considered for admission to Ph.D. degree by the research degree committee (RDC), declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate (or its equivalent grade 'B' in the UGC 7- point scale or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose or assessing, accrediting or assuring quality and standards of educational institutions.

- A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-abled candidates.
- The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the category mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.
- Provided that the concerned subject in Agricultural Economics - M. Sc. (Ag) in Agricultural Economics or in allied disciplines – Master's degree in Dairy Economics /Animal Husbandry Economics/ Veterinary Economics/Fisheries Economics would be eligible. M.Com. or M.Sc. (Ag) in Agriculture Economics may be permitted to work for Ph.D. degree in Economics in the Faculty of Art.
- Provided further that an M.A. or M.Sc. in Mathematics may be permitted to work for PhD degree in Statistics in the Faculty of Science.
- In Faculty of Ayurveda, however, a candidate having M.D. (Ayurveda) degree in the subject concerned or equivalent degree of another University recognized by this University with at least 60% (55% for SC/ST/ Differently- abled candidates) marks shall be eligible for admission to the Ph.D. programme in Ayurveda.
- In the faculty of Medical Biochemistry, a candidate holding post-graduate degree in the concerned or allied subjects or equivalent degree of another University recognized by this University/having a post graduate degree with at least 60% (55% for SC/ST/ Differently-abled candidates) marks shall be eligible for admission to the Ph.D. programme.
- Research on living authors is not permissible.
- Students appearing for final year or final semester of their post-graduate degree examination will also be eligible to appear for the admission process subject to the fulfilment of eligibility criteria in the final result thereof.

Note:

Candidates are advised to check their eligibility to appear for the CSJMU-ET 2022. The organizing institution will not verify your eligibility. Your eligibility will be verified at the time of counselling with original testimonials/documents.

Selection Process:

The University shall admit Ph.D. students through an entrance test named as “Chhatrapati Shahu Ji Maharaj University Entrance Test (CSJMU-ET)” for Ph.D. admission. Subject to the provisions contained in clause (8) of section 7 of the Uttar Pradesh State Universities Act, 1973, CSJMU-ET shall be conducted in specified subjects/disciplines by the University. The dates of written test for respective fields will be announced through the website of the University. The shortlisted candidates eligible for interviews will be informed through website of the university. The University reserves the rights to conduct the entrance process or direct interviews depending upon the number of applications in the particular subject.

University shall admit candidates by a two-stage process through:

- (i) Qualifying as an Entrance Test which will contain 100 multiple-choice objective-type questions of 4 marks each (maximum 400 marks) and shall consist of 50% of research methodology and 50% shall be subject specific of two hours duration for assessing subject expertise, subject proficiency and subject knowledge.
- (ii) There shall be negative marking. On each wrong answer, one mark will be deducted. Four marks would be granted for correct answers and no marks would be awarded/deducted for un-attempted questions.
- (iii) The entrance result shall be prepared by estimating the percentile of marks obtained in entrance test. Percentile score will be used for preparation of the entrance merit list. Top 50 percentile of each subject will be called for the interview. Final merit would be prepared based on total marks of the interview and entrance test score for each subject along with weightage wherever applicable. Final result would be declared as percentile for each subject.
- (iv) The shortlisted candidates shall appear for interview and presentation before a Screening Committee constituted for respective fields on the date(s) announced through the website of the University. The candidates based on their overall performance will be categorized as selected or not selected for Pre-Ph.D. coursework.
- (v) The final list of candidates selected will be announced through the website of the University.

Exemptions from the Entrance Test:

The following categories of candidates shall be exempted from the Entrance Test for admission to Ph.D. Program:

- ✚ International students (including NRIs) which shall be subject to the general rules framed by the Government of India from time to time and as applicable to the University with regards to the admission, fees etc.
- ✚ Candidates who have secured grants for research such as fellowship/scholarship/associateship etc. from UGC(JRF) / CSIR(JRF) / GATE-MHRD Scholarship / Teacher Fellowship / DBT/ ICMR/ICAR/DST-INSPIRE fellowship, DST-WoS or equivalent national level fellowship (as identified by RDC).
- ✚ Serving Army, Navy and Air-force Officers of at least Colonel or equivalent rank with not less than 15 years of service applying for Ph.D. degree in concerned or relevant disciplines.

No Exemption from Entrance Test

i) Permanent Assistant Professors, Associate Professors and Professors having appointment on regular posts in the teaching departments of the University or a government college / government aided college affiliated / associated to the University who have completed their probation successfully would be required to appear in the entrance examination. Weightage of 10% would be given for these candidates.

ii) Full time teachers of the self-financed courses run by the University/affiliated colleges on long term contract with at least three years of teaching experience in the university/college would be required to appear in the entrance examination. Weightage of 10% would be given for these candidates.

iii) GATE, NET, SLET qualified candidates would be required to appear in the entrance examination. Weightage of 10% would be given for these candidates.

Note: In case, number of candidates passing JRF or Entrance examination (final merit) are more than the number of vacancies in a particular subject, their marks in post-Graduation will be taken into account to decide the merit for their admission in Ph.D. programme.

Details of Fee

Application Fee

- Application Fee (for each subject) is **Rs. 2500/-** for Unreserved and OBC category and **Rs. 1500/-** for SC/ST category and PwD subcategory.
- Please note that this fee is non-refundable under any circumstances. Payment of application fee has to be made through online payment mode only.

PhD Course Fee

- PhD course fees (Unreserved and OBC)- **Rs. 35000/-** per year
- PhD fees (for SC/ST category and PwD subcategory)-**Rs. 25000/-** per year

CSJMU Kanpur PhD Admission 2022 Application Process

- The Ph.D. Application form has to be filled online for admission to the Ph.D. Program.
- The Online Application form will be filled by all the candidates. Candidates in exempted category, non-exempted category or part-time PhD would be required to fill the application form and submit the required fee.
- The envelope containing the application form should be superscribed as “Application for Ph.D. Entrance 2022” and name of the subject should be clearly mentioned on the envelope. The hard copy of the printed application form with required documents should reach on or before 11/05/2022 on the following address:

Admission Guidelines for the Academic Session 2022-2023

1. After declaration of Result of CSJMU-ET, candidates should download the results from CSJMU website.
2. The website will display the supervisors list and seats available in respective subjects being offered in the CSJMU campus or respective colleges.
3. Qualified candidates are requested to bring their documents in original during interviews for verification.
4. Candidates are requested to prepare a brief presentation of their proposed research work for their interview.
5. Shortlisting in the entrance test and appearing in the interview does not guarantee admission in the PhD program of CSJMU, Kanpur.
6. Confirmation of admission is subject to fulfilment of required eligibility conditions/criteria set by CSJM University.
7. Any further update/information about admission process will be displayed on the website of the University.
8. CSJM University does not approach individual student for interviews, therefore students are requested to regularly check the website for updates.
9. No further chance would be given to any candidate who is not available for entrance test/interviews.
10. Candidates are requested to submit their required fee in the time-frame specified by the University.
